

These desiccant packets are available in both, reel and cut form. Cut pouches are directly fed into vibrator bowls and through dispensers directly dispense into the bottle, where as in case of reel form it requires to mount on cutting machine and after cutting directly dispensed into the bottle.

In cut form sachets are cut to the top edge of the sealing area, in case of reel form, there will be space between the pouches for easy cutting.
